



MASTER WARRANTY STATEMENT

Aluminum Fence Products- Full Warranty

BASTEEL Perimeter Systems products covered under this warranty include:

Architectural Fencing

Zephyr
Tempest

BASTEEL Perimeter Systems is committed to designing and manufacturing its products for maximum performance, longevity, and value. All horizontal louver blades and channels are extruded from a series 6000 aluminum. All aluminum components are coated with a thermo-cured powder coating process and paint that meets or exceeds the performance characteristics of AAMA-2604/AAMA-2605.

BASTEEL Perimeter Systems aluminum fence products are guaranteed under normal and proper usage against cracking, chipping, corrosion, chalking, peeling, and warping for a fifteen (15) year period from the shipping date. BASTEEL Perimeter Systems aluminum fence products are also guaranteed for the same period of time against defects in workmanship or materials. This warranty does not apply to any product (a) for which the buyer has failed to make payment when due; (b) has been subjected to abuse, misuse, neglect, negligence, accident, improper testing, improper installation, improper storage, improper handling, abnormal physical stress, abnormal environmental conditions for a purpose other than which it was designed and/or disclosed to BASTEEL or use contrary to any instructions issued by BASTEEL; or (c) has been reconstructed or altered by persons other than BASTEEL or its authorized representative.

The following acts and/or omissions will void the subject warranty:

- All BASTEEL products must be used for the purpose for which they are originally manufactured and sold
- All BASTEEL products must be installed according to BASTEEL's recommendations
- Purchaser must inspect and maintain BASTEEL products regularly during this warranty period
- Any alteration to the product itself by the property owner including any on-site cutting or welding
- Installation within 10 miles of a saltwater coastline may be grounds to void or reduce any warranty obligation at the discretion of BASTEEL Perimeter Systems
- Damage to the product caused by the property owner by use of landscape, gardening equipment, chemicals that may cause damage, and/or water sprinklers with high mineral content
- Damage to the product caused by adhesion of chicken wire, chain link mesh, welded wire, or other similar substance

Note: Items not manufactured by BASTEEL are not covered under this warranty.

Should any BASTEEL aluminum fence product fail in accordance with any of the above conditions, BASTEEL warrants to the original purchaser their redemption through replacement, renewal/repair, or issuance of a pro-rated credit. The choice of redemption method is solely at the discretion of BASTEEL.

Notice of failure under the conditions of this warranty shall be sent to BASTEEL in writing together with proof of purchase and shall specify the nature of the defect, when it was first observed, as well as photographs of the current site conditions. This guarantee does not apply when failure or damage is due to improper use or application, improper installation, abuse or misuse, vandalism, or acts of God.

Upon acceptance of the claim by BASTEEL, redemption by replacement, renewal/repair, or issuance of a pro-rated credit shall be made by BASTEEL. BASTEEL reserves the right to select the qualified company or individual to perform the labor to repair or replace the components that are deemed to be defective under the terms of this warranty.

The above constitutes the complete warranty by the manufacturer. No other agreement, written or implied, is valid. BASTEEL Perimeter Systems does not authorize any other person or agent to make any other express warranties. BASTEEL neither assumes nor authorizes any other person or agent to assume any other liability in connection with the BASTEEL Perimeter Systems aluminum fence products.
